I never worked under a forest management plan. I think the FB expressed interest in having a plan, but we decided that since the entire forest had just been significantly logged, with the exception of the Lange block, that we would treat the Lange Block, and then do a comprehensive plan. We were nearly to that point, when I was dismissed.

I did the following timber sales at the Lange Block.

The following April, I was informed that the Forest Board was unhappy with the messiness of recent work, especially slash in trails that they wanted to use as ATV trails, and they wanted to chip on our next sale. I made the case that significant access improvements would need to be made to do that, and that the equipment needed to harvest/process whole-tree chips was not appropriate in the area that remained to be harvested. The Forest Board met in May 2010 and I was dismissed.
