Tad, is your take on this statute a legal opinion or yours or someone else's understanding?

Is this what we are looking at? See: <u>https://legislature.vermont.gov/statutes/section/24/033/01061</u>

If so, that statute clearly states that any sale of real property requires one of 2 methods of public involvement. One is via a 30-day public notice, with voters' right to appeal. The other is via a town vote.

There is one way it can be accomplished without public involvement. I have not checked our town charter as, I think you may have by now? I don't think it's on line. Have you had anyone else read the statute, just to be sure your understanding is correct? Has anyone else looked it up and read it?

I'm not a lawyer, but I have asked a couple of folks to make sure my age hasn't interfered too much.

Did you really check with the Division of Forests? Who was it?

The taxpayers clearly need a voice here. The SB has turned my good faith work for them last summer, at their request and with their full cooperation and encouragements into threats and intimidation toward me. I can take it, but with every one of these reactions to my still-good-faith attempts, you dig a deeper hole for the taxpayers.

## Bill,

From what I have learned from VLCT – MAC (Municipal Assistance Center attorney) and from the VT Agency of Natural Resources, Forestry Division the VT State statute 24 VSA 1061 applies unless as part of the agreement the town is leasing timber rights to the land. To my knowledge, the Town has not ever leased timber rights to the land. Further, it is completely within the authority of the Selectboard (to appoint someone or a board) to enter into a timber sale contract. There is no language indicating the Town must seek Town voter approval to enter into a timber sale contract.
